Church responsibility

New teams must receive core training through approved trainers or via our online training. We recommend that Storytellers attend their denomination's Safeguarding training and a session with the school's Designated Safeguarding Lead (DSL), or Designated Senior Person (DSP). New Team Leaders should contact OtB for support and advice. Storytellers should, where possible, attend a local training event annually which will include a safeguarding update, and remain up to date with their church's safeguarding policy.

Team Leaders should ensure that all safeguarding matters, relevant policies and procedures and the Safeguarding Code of Conduct are discussed with their teams once a year. This will ensure everyone is up to date and aware of how to deal with any safeguarding concerns with respect to children or volunteers.

All Storytellers should conduct themselves in accordance with the reasonable expectations of someone who represents the church. Volunteer Storytellers delivering OtB assemblies/acts of collective worship should not be left with children on their own. School staff should always be present at each assembly/act of collective worship.

- Never be alone with a child in school.
- There should be minimal physical contact with children during an assembly/act of collective worship.

All Storytellers agree to:

- Stick to the script and present the story simply, without addition or deviation, following the guidelines in the Open the Book Handbook
- Allow each story to speak for itself, as a Bible story, not as a sermon
- Liaise closely and sensitively with schools, and be mindful of the educational environment
- Be aware that they are invited guests and make minimal demands on schools
- Show respect and sensitivity to those of other faiths, and to those with none
- Fulfil the relevant safeguarding requirements
- Uphold the copyright of Open the Book material

Storytellers must be accompanied by members of staff during all assemblies/ acts of collective worship.
